# PROFESSIONAL LICENSURE DISCLOSURES

New York State takes pride in the high quality of its licensed and certified professionals. For the protection of its citizens, each license and certificate has requirements that individuals must meet in order to be licensed or certified in New York State. SUNY's academic programs leading to licensure or certification are carefully designed to meet and exceed these State requirements and those of <u>related accrediting agencies</u>. This is a role SUNY plays in protecting the public.

Effective July 1, 2024, federal regulation requires institutions of higher education to make a determination whether a Title IV-eligible academic program that leads to professional licensure or certification meets the educational requirements for licensure/certification in:

- · the U.S. State where the institution is located and
- the U.S. States where "distance education" students are located at the time of initial enrollment in the program<sup>1</sup> or, if applicable, the U.S. State where such students attest they intend to seek licensure/ certification and employment, and
- the U.S. States where the program is advertised as meeting such requirements.

**SUNY New Paltz's licensure/certification programs** are registered by the New York State Education Department and thus **meet** the educational requirements for licensure/certification in **New York State**.

In addition, SUNY New Paltz's undergraduate engineering programs:

- · Computer Engineering (BS)
- · Electrical Engineering (BS)
- · Mechanical Engineering (BS)

are accredited by the *Engineering Accreditation Commission of ABET*. Graduates from ABET-accredited bachelor-level engineering degree programs have met the educational requirements for licensure in all U.S states and territories:

Alabama, Alaska, American Samoa, Arizona, Arkansas, California, Colorado, Connecticut, Delaware, District of Columbia, Florida, Georgia, Guam, Hawaii, Idaho, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, the Republic of the Marshall Islands, Maryland, Massachusetts, Michigan, the Federated States of Micronesia, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Jersey, New Mexico, New York, North Carolina, North Dakota, Commonwealth of Northern Mariana Islands, Ohio, Oklahoma, Oregon, the Republic of Palau, Pennsylvania, Commonwealth of Puerto Rico, Rhode Island, South Carolina, South Dakota, Tennessee, Texas, Utah, Vermont, Virgin Islands, Virginia, Washington, West Virginia, Wisconsin, Wyoming

and thus are eligible to become registered professional engineers (PE) in all U.S. states/territories by a process of two examinations (the FE and PE exams) and documentation of engineering work experience.

**All other programs listed below do not meet** the educational requirements for licensure/certification in the following U.S. States and Territories:

Alabama, Alaska, American Samoa, Arizona, Arkansas, California, Colorado, Connecticut, Delaware, District of Columbia, Florida, Georgia, Guam, Hawaii, Idaho, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maine, the Republic of the Marshall Islands, Maryland, Massachusetts, Michigan, the Federated States of Micronesia, Minnesota, Mississippi, Missouri, Montana, Nebraska, Nevada, New Hampshire, New Jersey, New Mexico, North Carolina, North Dakota, Commonwealth of Northern Mariana Islands, Ohio, Oklahoma, Oregon, the Republic of Palau, Pennsylvania, Commonwealth of Puerto Rico, Rhode Island, South Carolina, South Dakota, Tennessee, Texas, Utah, Vermont, Virgin Islands, Virginia, Washington, West Virginia, Wisconsin, Wyoming.

SUNY New Paltz may not enroll a student physically located in these states/territories unless:

- (1) the student signs a written attestation verifying their intent to seek licensure/certification in New York State or another state whose educational requirements are met by New Paltz's academic program, or
- (2) New Paltz determines that its academic program meets the educational requirements for licensure/certification in the state/territory in which the student is located.

- All BA or BS Adolescence Education programs lead to eligibility for New York State initial certification to teach the listed subject in grades 7-12.
- All MAT Adolescence Education and dual-degree (BA/MAT, BS/MAT) programs lead to eligibility for New York State initial/professional certification to teach the listed subject in grades 7-12.
- All MSED Adolescence Education programs lead to eligibility for New York State professional certification to teach the listed subject in grades 7-12.

**Bilingual Education Extension** (<u>Adv Cert</u>) - leads to eligibility for New York State initial/professional bilingual/teacher extension

Childhood Education (MSED, MST 1-6, MST B-2 & 1-6)

- MSED Childhood Education leads to eligibility for New York State professional certification to teach grades 1-6.
- MST Childhood Education leads to eligibility for New York State initial/ professional certification to teach grades 1-6 or birth to grade 2 and grades 1-6.

Communication Disorders (MS; accredited by ASHA) - The concentration in Speech & Language Disabilities leads to eligibility for New York State initial/professional or professional Speech/Language Disabilities teaching certification (TSSLD).

**Early Childhood & Childhood Education** (BS) - leads to eligibility for New York State initial certification to teach birth to grade 2 and grades 1-6

**Literacy Education** - All Grades (<u>MSED</u>)- leads to eligibility for New York State initial/professional Literacy certification for all grades

School Business Leadership (Adv Cert) - leads to eligibility for New York State professional School Business Leader certification

**School Counseling** (MS; accredited by CACREP) - leads to eligibility for New York State initial/professional School Counselor certification

School Leadership (Adv Cert) - leads to eligibility for New York State initial/ professional School Building Leader certification and professional School District Leader certification

**Second Language Education** (MSED) - leads to eligibility for New York State initial/professional ESOL teacher certification

Social Justice Educational Studies (MPS) - leads to eligibility for New York State professional certification to teach special subjects (family/consumer science, health, music, physical education, technology education)

**Teaching English to Second Language Learners** (<u>Adv Cert</u>) - *leads to eligibility for New York State initial/professional ESOL teacher certification* 

**Teaching Students with Disabilities - All Grades** (MSED) - leads to eligibility for New York State initial/professional SWD certification to teach students with disabilities in all grades; also leads to eligibility for multiple subject-area extensions

Visual Arts Education (BS, MAT, MSED)

- BS Visual Arts Education leads to eligibility for New York State initial certification to teach Visual Arts to students in all grades.
- MAT Visual Arts Education leads to eligibility for New York State initial/ professional certification to teach Visual Arts to students in all grades.
- MSED Visual Arts Education leads to eligibility for New York State professional certification to teach Visual Arts to students in all grades.

**World Language Education** (MAT) - leads to eligibility for New York State initial/professional certification to teach French and/or Spanish in grades 7-12.

## **Licensure-Qualifying Programs**

**Accounting** ( $\underline{MS}$ ) - leads to eligibility for CPA-150E licensure in New York State

Behavior Analysis & Interdisciplinary Autism Studies (MS) - leads to eligibility for Behavior Analyst licensure in New York State. The program fully complies with the BACB's Pathway 2 behavior-analytic coursework eligibility requirements for the Board Certified Behavior Analyst (BCBA).

**Counseling Programs** - lead to eligibility for Mental Health Counselor licensure in New York State:

Clinical Mental Health Counseling (MS; accredited by CACREP)
Mental Health Counseling (Adv Cert)

**Communication Disorders** (MS; accredited by ASHA) - leads to eligibility for Speech-Language Pathology licensure in New York State.

Geology (BS) - leads to eligibility for Geologist licensure in New York State

Music Therapy (MS; accredited by NASM and approved by AMTA) - leads to eligibility for Creative Arts Therapist licensure in New York State

Public Accountancy (MBA; accredited by AACSB) - leads to eligibility for CPA-150 licensure in New York State

It is important to note that SUNY New Paltz is not the licensure/ certification authority in any U.S. States/Territories and cannot assess whether an individual candidate will be issued a license/certificate in any U.S. States/Territories.

#### **Student Complaint Resolution**

If a student is dissatisfied with the campusbased resolution, a concern may be submitted to System Administration of the State University of New York. If still not satisfied, a complaint may be submitted, within two years of the incident about which the complaint is made, to the New York State Education Department. Please note, this does not include complaints related to grades or student conduct violations, both of which are to be fully addressed via campus processes, not through the NC-SARA complaint resolution procedures.
